## Setting the Stage and Safe Spaces

We want our adolescents to feel safe and supported

Setting a time where both parties are likely to be engaged is crucial to online safety

Preparing for the conversation: Have all materials ready (ex. Contract or app open to share), prime your teen to think about what's important for them in their online use in advance of the conversation(ex. How late can they have access to the wifi...)

Think about and agree to boundaries and guidelines (see contract)

Regularly revisit the discussion

## **Open and Clear Communication**

- Have a conversation listen to your adolescent, don't just provide them with information
- Getting and keeping their attention... use their name, make sure they're paying attention before you ask a question or give an instruction, use interests to engage them
- Processing information... don't include irrelevant information, say less and say it slowly, repeat specific keywords, give time to process and a chance to think of a response, use less nonverbal communication, use visual supports if appropriate, be aware of environment

## **Open and Clear Communication**

- Avoid open-ended questions... keep questions short, only ask the most necessary questions, be specific in what you're asking
- Being clear... avoid using sarcasm, irony, figurative language, rhetorical questions, idioms, exaggeration, as they can be taken literally.



## **Questions to Consider Asking...**

- What are some examples of types of information we don't give out online?
- 2) Who are two adults who you can trust to help you be safe online?
- 3) If something makes you sad, scared, or uncomfortable, what should you do? (walk through the plan, step by step)
- 4) Are there any types of content or sites online that may be inappropriate? Why?
